## **Description Of Change:**

Bumping site change for Cu Pillar bump products from Chipbond, Taiwan (CB1) to Chipbond, Taiwan (CB4).

- Same assembly build specification used in CB1 will be used in CB4.
- Same bumping mask set used in CB1 will transfer to CB4.
- Equipment set in CB1 will transfer to CB4.

#### Reason For Change:

Chipbond is consolidating all non-Au bump products to their Chipbond 4 (KF) Plant. Non-Au bumping products will move to CB4 where several of ADI's parts are bumped.

ADI's assembly subcontractors manufacture our products using Analog Devices specified manufacturing flows, materials, process controls and monitors. This assures that our customers receive the same level of quality and reliability on products they receive from different manufacturing locations.
