# **Product Change Notice**

# Change Description:

Datasheet change to ACFJ-3530T

### Parts Affected:

ACFJ-3530T-000E ACFJ-3530T-500E

## **Description and Extent of Change:**

- 1. Change CSA approval from Notice #5, File CA 88324 to CAN/CSA-C22.2 No.62368-1
- 2. Under IEC/EN/DIN EN 60747-5-5 table:
  - a. Remove Insulation Classification for rated mains voltage ≤ 1000 Vrms
  - b. Change Input Power (P<sub>S,INPUT</sub>) = 400mW to Input Current (P<sub>I,INPUT</sub>) = 400mA
- 3. Under ESD Ratings table:
  - a. Change Human Body Model classification from C2 to 2
  - b. Change Charge Device Model classification from C4B to C2a
- 4. Under Electrical and Switching Specification table:
  - a. Change maximum value of /UVLO Logic High Output Current (I/UVLO H) from 1µA to 10µA.
  - b. Change maximum value of /FAULT Logic High Output Current (I/FAULT\_H) from 1µA to 10µA.

## **Reasons for Change:**

- 1. CSA Notice #5 is obsoleted.
- 2. Under IEC/EN/ DIN EN 60747-5-5 table:
  - a. Not relevant specification for this part.
  - b. Typographical error. Input IC power is stated under Absolute Maximum Table.
- 3. Under ESD Ratings table:
  - a. Change is updated per AEC Q100-002 REV-E
  - b. Change is updated per AEC Q100-011 REV-D
- 4. Under Electrical and Switching Specification table:
  - a. Typographical error of "1" vs "10" during data sheet compilation
  - b. Typographical error of "1" vs "10" during date sheet compilation

# Effect of Change on Fit, Form, Function, Quality, or Reliability:

The device electrical performance remains the same. Appropriate electrical characterization and reliability qualification has been performed on representative products to ensure normal parametric distribution, consistent electrical performance, and reliability.

Product shipments using this change will begin after 30/01/2022.
