# **Description of Change:**

Cypress announces the qualification of STATS ChipPAC Jiangyin, China (JSCC) as an additional assembly site for select BGA products as STATS ChipPAC has announced that they will be discontinuing these packages at STATS ChipPAC Shanghai, China (SCC) due to a planned site shutdown. Both STATS ChipPAC sites are certified on the ISO9001 and TS16949 international quality standards.

The change will not affect current product structure, process flow, BOM material, equipment or operations as all are the same between the two production sites. There will be no change to the product quality, form, fit or function.

Cypress plans to transition from shipments of the original BCM marketing part number parts to shipments of the new CYW marketing part number parts in July 2017.

The BGA packages are assembled at STATS ChipPAC Jiangyin, China (JSCC) and STATS ChipPAC Shanghai, China (SCC) using the following Bill of Materials:

### **Approximate Implementation Date:**

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of the affected part numbers in the attached file will be assembled at STATS ChipPAC Jiangvin, China (JSCC) or other approved assembly sites.

## **Anticipated Impact:**

Products assembled at the new site are completely compatible with existing products from a functional, parametric, and quality performance perspective.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

### **Method of Identification:**

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
