Firmware	The PCIe Sub-system (PCIESS) LTSSM supports Link Training states and Re-Training (Recovery) state. However, the PCIESS does not support any software driven power management states such as L2P2, as incorrectly noted in the original documentation.	Software-driven power management states such as L2P2 in PolarFire PCIESS Root-Port and Endpoints are not supported.

Reason for Change:Software-driven PCIe L2P2 entry commands issued by the PolarFire PCIESS Root-Port to the downstream end-points are not supported. As a root-port, this will cause the link to be completely disrupted and only recoverable by re-initializing the link with side-band PERSTn (fundamental reset) or a power cycle.

PolarFire PCIESS End-point should not be commanded by the host to enter L2P2 link state. As an end-point, the link may be disruptive and only recoverable by re-initializing the link with side-band PERSTn (fundamental reset) or a power cycle.
