Change Description	This letter is to inform you of a packaging change on guided Impact 100 Ohm 2 Pair backplane headers. The finger hole size in the base of the tray is being reduced to prevent parts at the end of the pocket row from sliding out of pocket into the finger hole, which in turn damaged the tails during shipping and handling. This is not an issue for unguided headers. There is no changes to the SPQ or MOQ due to this change. Qualification Test will be conducted to qualifed the new packaging.
