Details of this change

Vanguard International Semiconductors (VIS) have informed Nexperia that they will extend their manufacturing capability to include sample wafer test and associated processing steps within their sites in Taiwan. Having this vertically integrated capability reduces their reliance on their external parties and improves production workflow. Finished product will be unaffected by this change as assembly and final test of the products remains unchanged.
