



The change will start in the first half of 2021. During this period, mixed deliveries are possible. We expect to deliver all affected items with the changed design starting on 2021-07-01. No other technical or electrical data of the items will be affected by this change. With this product change, due to the PROFINET standard and its user organization (PNO) and the resulting
