PCN Transfer of production from Málaga to Zhuhai and Gravataí

The production of EPCOS film capacitors of the B3265*, B3267*, B3275* and B3277* series is being relocated from Málaga, Spain, to the plant in **Zhuhai**, China. Exceptions to this are the types of the B3267* and B3277* series with the letter J at position 7 of the ordering code (B32678J* and B32778J* – BrickCap), whose production will be relocated from Málaga to our plant in **Gravataí**, Brazil.
