Tapes should be stored in a dry, well ventilated room with a reasonably consistent temperature of 68°F (20°C) and be protected from exposure to direct sunlight. Tape should not be stored in ultraviolet sunlight, moisture, or heat. Tape over one year old should be evaluated by the user to determine acceptability for the user's application. Desco Industries, Inc. recommends those tracking useful life of product to use shipping/invoice date as Desco Industries, Inc. expressly warrants that for a period of one (1) year from the date of purchase, our Wescorp Brand ESD Tape will be free of defects in material (parts) and workmanship (labor). 
