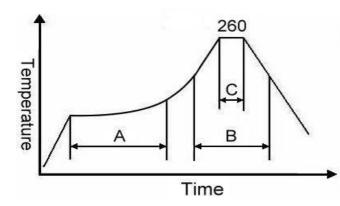

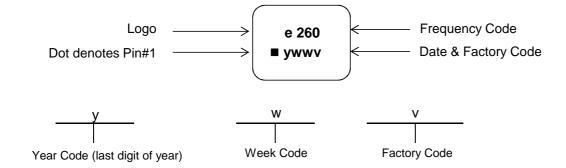

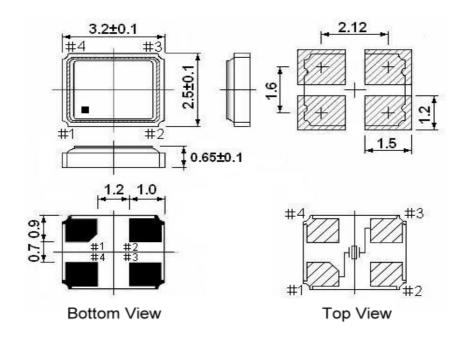

Recommended Land Pattern



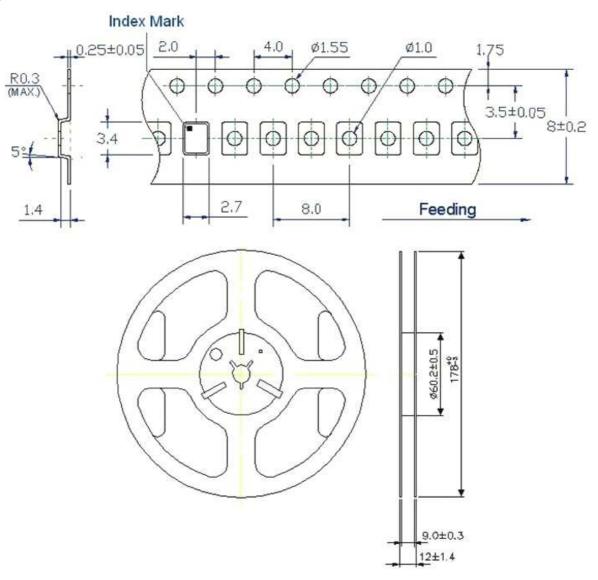
